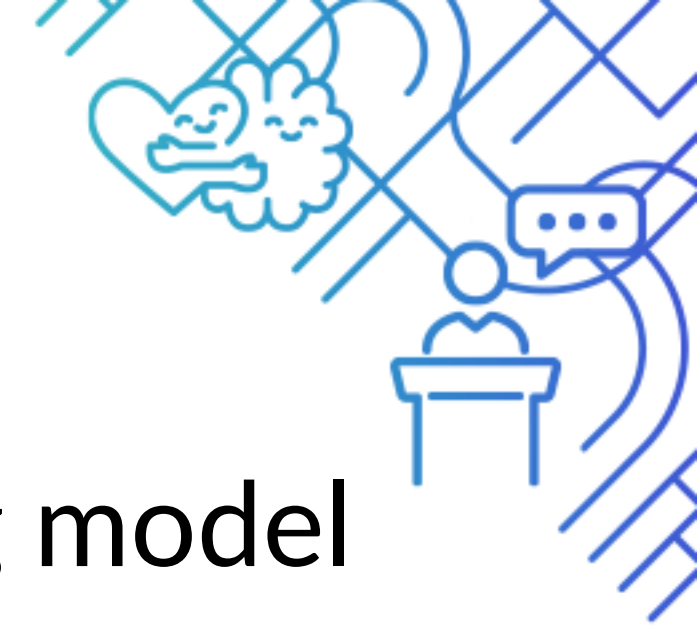

Bridgespan: Project Goal

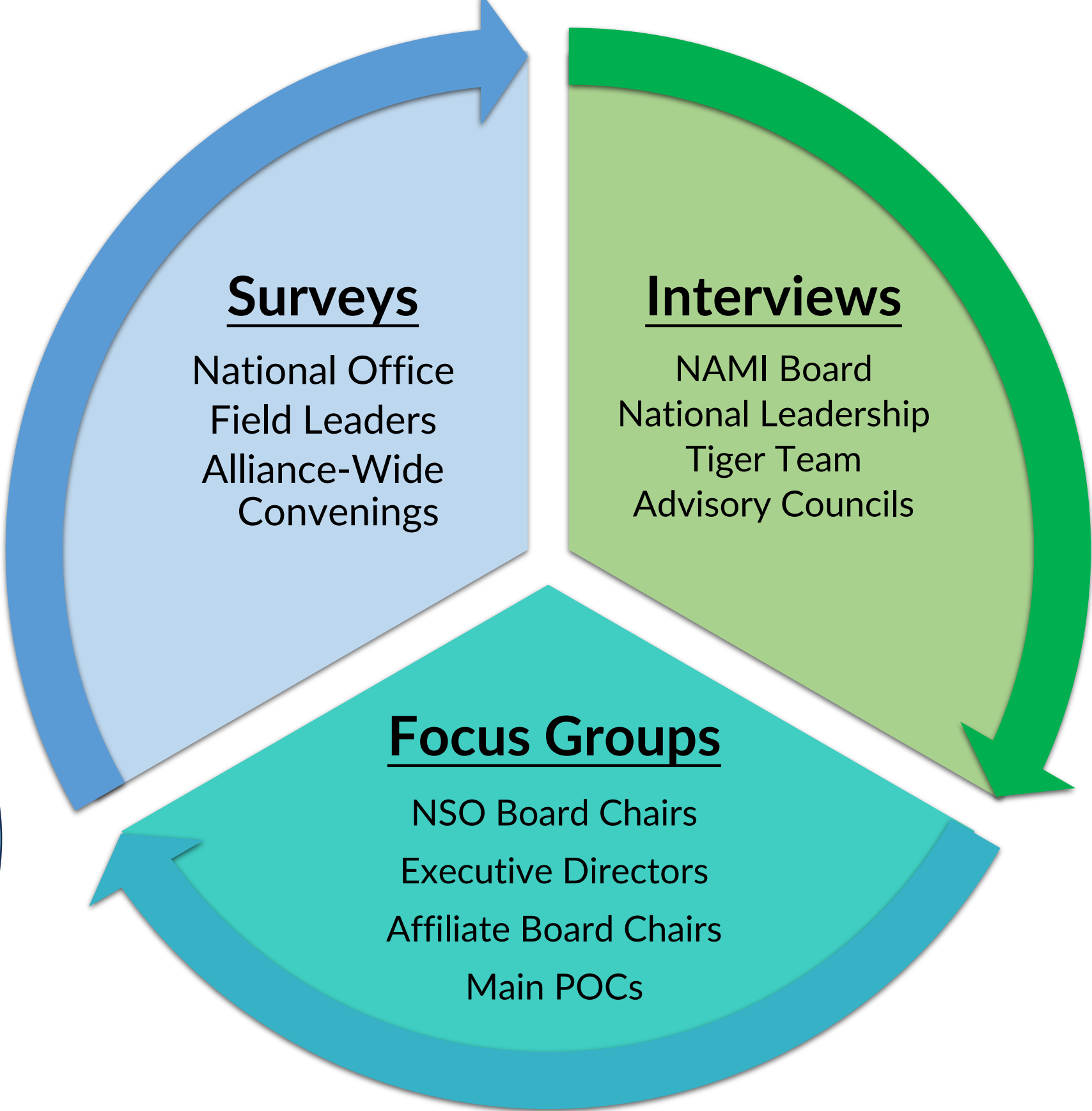


Create a more **constituent-centric** operating model

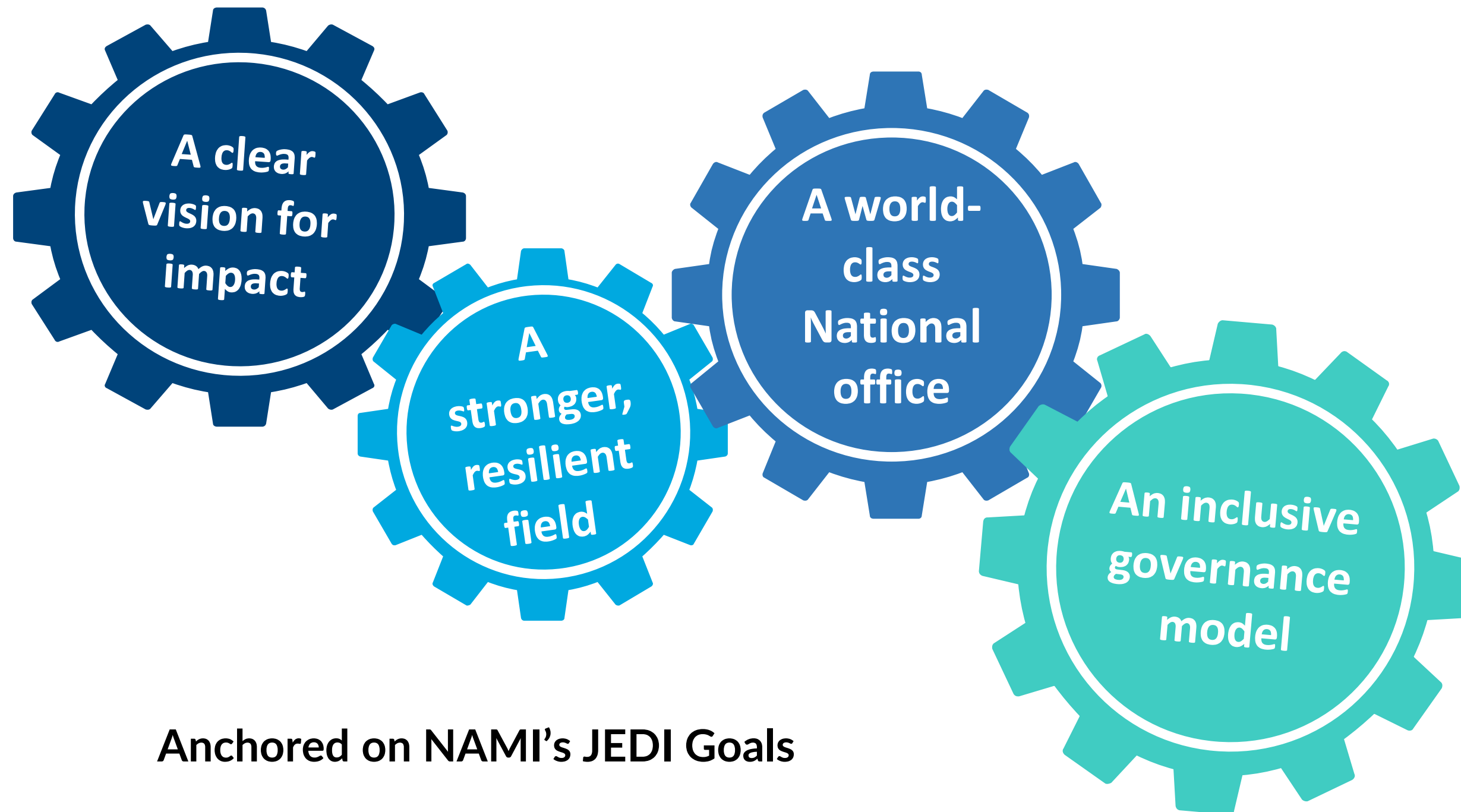
